

SUMMARY ANNUAL REPORT

This is a summary of the annual report of the Anywhere Real Estate Group LLC Health and Welfare Plan, EIN 20-4381990, Plan No. 501, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Anywhere Real Estate Group LLC has committed itself to pay certain self-insured Medical, Short-term Disability, and Employee Assistance Program claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with National Union Fire Insurance Company of Pittsburgh, PA, Hawaii Medical Service Association, Vision Service Plan, Cigna Health and Life Insurance Company and Affiliates, Kaiser Foundation Health Plan, Inc., Metropolitan Life Insurance Company, Metropolitan General Insurance Company, and Reliance Standard Life Insurance Company to pay Medical, Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Business Travel Accident, Legal, Critical Illness, Hospital, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$8,323,655.
